As announced in May 2019, Federated will acquire certain assets from the PNC Financial Services Group. Pending shareholder approval, as of the close of business on **Friday**, **November 15**, **2019**, various PNC Funds will reorganize into Federated Funds as noted below. The fund reorganizations are anticipated to be tax-free events for shareholders of the funds.
