

# Legg Mason Product Updates

As part of our ongoing commitment to keep you informed about our product line-up, included below are updates to existing products offered by Legg Mason.

## **PERMAL ALTERNATIVE CORE FUND – EXPENSE CAP REVISION**

### **Effective February 1, 2016**

The Board of Trustees of Permal Alternative Core Fund has approved a number of changes to the Fund's expense caps:

- Exclusion of (i) Acquired Fund Fees and Expenses (AFFEs) and (ii) dividend & interest expenses on securities sold short from expenses covered by contractual expense caps;
- Reduction of contractual expense caps across all share classes and extension of expiration dates to December 31, 2017;
- Implementation of voluntary expense caps at the total shareholder expense level across all share classes expiring December 31, 2016.

These changes align the Fund with policies which are generally consistent among other funds in its peer group and are effective February 1, 2016. Further details regarding the new contractual/voluntary expense caps can be found in the attached spreadsheet.

#### **Shareholder communication:**

These changes are reflected in a prospectus supplement dated November 4, 2015 (attached), which will be mailed to existing shareholders.

## **CLEARBRIDGE MID CAP CORE FUND – NAME CHANGE**

### **Effective January 4, 2016**

ClearBridge Mid Cap Core Fund will change its name to ClearBridge Mid Cap Fund. The Fund's investment objective, policies and strategies will not change as a result of the name change.
