<u>Fund Merger Announcement:</u> Effective Friday, December 20, 2019, the Principal Global Opportunities Fund will be merging into the Principal Diversified International Fund. Here are the details for the merger:

Dividend and/or Capital Gains payments may be paid as part of the merger with the dates below.

Record Date: Wednesday, December 18, 2019

o Ex-Date: Thursday, December 19, 2019

o Payable Date: Thursday, December 19, 2019

- Principal Funds will accept trades through the DTCC on the merging away funds until the dates indicated below. After the merger date, all DTCC and manual trades need to be submitted using the surviving CUSIPS.
- NSCC Trading will move to T+1 on Friday, December 13, 2019.
- Extended 4-digit NAV's will be provided the day of the merger. On Monday, December 23, 2019, the variance will be 4 decimal places for the surviving funds and will change back to 2 decimal places Tuesday, December 24, 2019.
- All account options from the merging away fund will carry over to the surviving fund.
- Non-Taxable merger transactions will use the following trans code/suffixes:
