

COLUMBIA FUNDS SHARE CLASS UPDATES

Share class renames

As previously communicated, Columbia fund R4, R5, Y and Z share classes will be renamed at the start of November 1, 2017, to Advisor, Institutional 2, Institutional 3 and Institutional, respectively. There are no ticker, CUSIP or fund number changes associated with these share class name changes.

Expanded Eligibility for Columbia Government Money Market Fund Class R

Effective November 1, 2017, Class R shares of Columbia Government Money Market Fund are no longer limited to investors in Columbia Management Investment Distributors, Inc.'s (the Distributor) proprietary 401(k) products. Class R shares of Columbia Government Money Market Fund will be available to eligible health savings accounts sponsored by third party platforms, including those sponsored by Ameriprise Financial affiliates, eligible retirement plans and, in the sole discretion of the Distributor, other types of retirement accounts held through platforms maintained by financial intermediaries approved by the Distributor. Eligible retirement plans include any retirement plan other than individual 403(b) plans. Class R shares are generally not available for investment through retail nonretirement accounts, traditional and Roth IRAs, Coverdell Education Savings Accounts, SEPs, SAR-SEPs, Simple IRAs or 529 tuition programs.

Minimum balance and initial investments for Columbia Absolute Return Currency and Income Fund, Columbia Floating Rate Fund, Columbia Inflation Protected Securities Fund only

Effective December 1, 2017, the minimum initial investment and minimum balance requirement for these funds is revised to align with our standard limits of: a \$100 minimum for Class A, Class C, and Class T shares with systematic investment plans; \$1,000 minimum for IRAs other than systematic investment plan accounts; and \$2,000 for all other accounts.
