

Coming Soon: Announcing a change to our DocuSign authentication designed to provide a greater level of security



As part of our commitment to security and reliability, we work with our partners to ensure we all meet current industry standards for information security.

We are enhancing our authentication standards with DocuSign which now requires Axos Advisor Services to obtain consent from our advisors to continue to send DocuSign envelopes from our Liberty application. This is a one-time consent.

We will begin the process of sending out emails allowing users to provide consent. The email will contain a link to DocuSign where users will be prompted to enter their DocuSign email address and password. Once authenticated into DocuSign, users can 'Allow Access' for our AAS Liberty application to continue to send DocuSign envelopes.

- Enter the email address where the consent email was received.

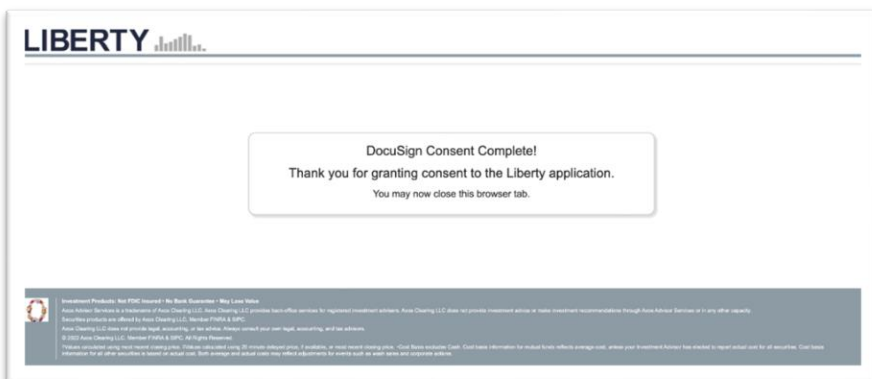
