## Directly Billed Statement Updates



In response to client feedback, we updated our verbiage around directly billed accounts on statements to provide clarity. Directly billed fees are fees that are directly billed to the account holder rather than the account and credited to the account before fee assessment. These fees are now broken out on the statement to help alleviate any account holder confusion surrounding fees.

If an account is marked as directly billed, it will state that on the comprehensive section on the front of the statement as well as on the fee breakdown page. The household account does not impact the rest of the accounts in the statement, including statement families. The directly billed verbiage is based on the individual account settings.
