On October 21, 2016 Eaton Vance Corp. announced an agreement to acquire the assets of Calvert Investment Management, Inc. It is anticipated that the acquisition will close on December 30, 2016.

Subject to the above close the attached list of Calvert Funds will be distributed by Eaton Vance Distributors under new DTCC # 2686. Any trades placed on December 30, 2016 or earlier in the Calvert Funds should be placed using the existing Calvert DTCC # 5543. Trades placed in the Calvert Funds on January 3, 2017 and going forward should be placed using the new Eaton Vance DTCC # 2686. It is imperative that you update your systems to reflect the change in DTCC number for only the funds listed below. **The DC College Savings Plan underwritten and distributed by Calvert Investment Distributors, Inc., will remain under DTCC # 5543.**

Official notification of the above acquisition will be provided under separate cover upon close of the transactions.

Settlement Up to Transition

- Beginning Tuesday, December 27, 2016, all CUSIPs of Calvert Funds listed below will have a T+1 settlement cycle for all purchases and redemptions.
- Beginning Tuesday, January 3, 2017, all CUSIPs of Calvert Funds listed below will revert to a T+3 settlement cycle for all purchases and redemptions.
- The DTCC will update the below list of CUSIPS to DTCC # 2686 after the 11:30 AM EST settlement cycle on January 3, 2017.

Networking Reporting

Networking Records (Activity, Dividend, Position, etc.) will begin being sent from DTCC # 2686 on Tuesday, January 4th.

Trail Accrual

The trail accruals will not be affected by the DTCC # change to the Funds. Trails that have accrued through December 31, 2016 will experience no change in the distribution process.

Mutual Fund Profile

Please be aware that over the next several weeks, the Calvert Funds' data will be moved from 5543 to 2686, with the exception of the CUSIPS related to the 529 Plan. We will provide notification when we have completed the transition of data to # 2686.
