- New accounts established with existing shares by transfer are allowed, such as change of broker, change
 of record keeper, conversion of existing shares of one class to another class, transfer-in-kind, divorce, death
 and charitable contribution.
- Intermediaries trading omnibus by fund accounts that want to retain the fund as an investment option for new investors should ensure their program fits the "Acceptable Omnibus Programs" description in <u>Information About Closed Funds</u>. If it does, you must email <u>cindy johnson@americancentury.com</u> by May 10, 2016, to request continued use of the fund. Approval and written authorization will be sent prior to the fund closing date.
- Employer-Sponsored Retirement Plan Recordkeepers who have committed to offering the closed fund in a new plan but will not invest assets by May 25, 2016, must email a list of plans, using the <u>ESRP Closed</u> <u>Fund New Business Form</u> to <u>cindy_johnson@americancentury.com</u> by May 20, 2016. An initial investment is required within 12 months after the closing date of the fund. NOTE: if a retirement plan currently has the fund as an investment option, and an account has been opened, but has no shares, the plan will need to be submitted on the <u>ESRP Closed Fund New Business Form</u> or will need to replace the fund with another option by close date.
