American Century® Legacy Focused Large Cap Fund: Investment Strategy and Name Change

Effective June 21, 2016, the Legacy Focused Large Cap Fund will enhance its investment strategy to include investing in early-stage, rapid-growth companies with large market opportunities, investing in a focused/limited set of holdings and reducing overall portfolio turnover*.

Additional updates to the fund include:

- Renaming the fund to Focused Dynamic Growth to better reflect its stated objectives.
- Switching the benchmark from S&P 500 to Russell 1000 Growth to better align with the fund's largecap growth investment focus.
- Changing investment managers—the fund will now be managed by the same teams that managed the Ultra and Select funds, led by portfolio managers Keith Lee, CFA and Michael Li, PhD.

The fee structure will remain the same. Shareholder approval is not required for these enhancements.
