## Upcoming Share Class Conversions of Class S to Class I

The most significant change from a systems standpoint will be four (4) share class conversions from existing Class S shares to Class I. Each of those four Funds will process the share class conversion immediately after the close of business on Friday, June 23, 2017. We certainly expect and encourage intermediaries to process exchange transactions out of Class S and into Class I, or one of the other available share classes in the respective Fund. For any accounts that remain on June 23, 2017, each shareholder's outstanding Class S shares will be systematically converted into Class I shares. The details on specific Funds/classes are listed below:
