## **Re: Certain Victory Funds Liquidations**

The Board of Trustees of Victory Portfolios and Victory Portfolios II has approved a Plan of Liquidation ("Plan") for the Victory Funds below (each a "Fund" and together the "Funds"). It is anticipated that the Funds will liquidate on or about December 15<sup>th</sup>, 2017. Any remaining shareholders on the date of liquidation will receive a distribution of their remaining investment value in full liquidation of the Fund.

Effective immediately, the Funds are closed to new shareholder accounts. Through December 8<sup>th</sup>, 2017, the Funds will continue to accept additional investments (including through the reinvestment of dividends and capital gains) from existing shareholders, including from participants in group retirement plans that currently hold shares of the Funds and customers of certain other financial intermediaries that maintain omnibus accounts with the Funds.

It is anticipated that the below liquidating Funds may make a final income and/or capital gain distribution. The anticipated Record, Ex and Pay dates are included below.
