Announcement Regarding Mirae Asset Discovery Funds (NSCC Participant Number 5322)

RE: Reorganization of Asia Great Consumer Fund into Asia Fund

On September 12, 2017, the Board of Trustees (the "Board") of Mirae Asset Discovery Funds (the "Trust") approved a Plan of Reorganization, which contemplates the reorganization of the **Asia Great Consumer Fund**, a series of the Trust (the "Acquired Fund"), with and into the **Asia Fund**, also a series of the Trust, (the "Acquiring Fund" and, together with the Acquired Fund, the "Funds"). The reorganization is expected to take effect approximately December 1st, 2017.

In anticipation of the reorganization, the Board has determined to close the Asia Great Consumer Fund to new investors effective October 16, 2017.

The reorganization of the Funds will be performed on a tax-free basis for federal income tax purposes. This tax-free treatment, however, does not extend to transactions that occur prior to, or after, the reorganization. During this time, the Acquired Fund may depart from its stated investment objectives and strategies.

It is anticipated that the liquidating Asia Great Consumer Fund may make a final income and/or capital gain distribution prior to the reorganization. The anticipated Record, Ex and Pay dates are included below.
