Delaware Funds by Macquarie acquisition of the First Investors Funds

As a follow-up to the acquisition announcement sent in April 2019, First Investors Funds will merge into new shell funds established by Delaware Funds by Macquarie. In connection with the transaction, Delaware Funds by Macquarie (Delaware) has filed shell fund CUSIPs for each of the First Investors Funds. Proxy filings and applicable regulatory approvals have also occurred; and subject to the required shareholder approvals, and other conditions of the merger transaction. These fund mergers are scheduled to occur on or about the close of husiness October 4 2019

Foresters Investor Services (FIS) is the transfer agent on the existing First Investors funds. FIS will act as the sub-transfer agent on the newly established Delaware funds at the time of the fund mergers. FIS currently maintains NSCC member # 5545. The new Delaware shell fund CUSIPs will be established under this 5545 membership number. All NSCC activity for these funds will occur under membership # 5545.

In the first half of calendar year 2020, these funds will transition over to the BNY Mellon platform (current sub transfer agent of existing Delaware Funds by Macquarie). Additional communications regarding the transfer agent system conversion will be provided later leading up to this event.

Questions and Answers

Will specifics related to the merger timeline be provided?

Will there be CUSIP changes in connection with the Transaction?

Yes, documentation for the CUSIP mapping and fund set up information are provided in this spreadsheet in the **From & To Funds** tab as well as the **New Delaware Shell Funds Info** tab.

Will the First Investors Funds NASDAQ symbols change?

No, NASDAQ symbols will carry over to the respective new Delaware shell funds.

How will the share classes be mapped between firms?

First Investors Fund share classes will be mapped to existing Delaware Funds share classes. Share class mapping is provided in the attached spreadsheet under the **Share Class Mapping** tab.

How will dividends be handled for daily accrual funds at the time of the Merger Transaction?

Daily accrual earnings will carry over to the Delaware shell funds and pay on the last business day of the month. (Record, Ex & Payable date)

Capital Gains and dividends information: There will be *no dividends and/or* capital gains on or prior to the Merger Transaction date as a result of the Merger Transaction. Any other distributions and/or capital gains will be in the normal course of business. Post merger, the newly established Delaware shell funds will retain First Investors Funds 2019 dividend and capital gains schedule. Accruals will carry over to the new Delaware funds. See **2019 Dividend Schedule** tab.

Will the frequency of dividend payouts change?

Two of the new Delaware shell funds will have a new dividend payout schedule. The **Delaware Total Return Fund** will change from Quarterly to Monthly. **The Delaware International Opportunity Bond Fund** will change to a Daily Accrual fund, and the frequency will change from Quarterly to Monthly. Will conversion ratios be provided when the Merger Transaction occurs?

Are the Delaware shell funds open to receive new assets prior to the merger transaction scheduled for 10/04/2019?

No, these funds will be available for purchase opening business 10/07/2019, after the merger transaction.

How will payment methods for 12b-1s and commissions be handled for the Delaware funds?

For the new Delaware funds, 12b-1's will be paid out monthly based on the rates described in the prospectus. Commissions will be paid out weekly based on the break point schedules described in the Delaware Funds prospectus.

How should sub-TA and 12b-1 invoices be handled?

When will the new Delaware shell fund CUSIPs be available in DTCC's Mutual Fund Profile II?

Note that your firm may not take in the files capturing future effective date changes but the new CUSIPs will be available in MF Profile on September 6th.

What is the impact to daily NAV files and rate delivery?

Will new agreements be needed for the new Delaware funds?

Generally, the new Delaware funds will be covered under any existing agreements you have in place for the existing Delaware funds. For certain financial intermediaries where there was not a pre-exiting relationship with Delaware Funds by Macquarie, we will enter new agreements.

Will you allow shareholders to group the new Delaware Funds on the FIS system with the Delaware Funds on the BNY Mellon system for ROA/LOI purposes?

Yes. However, the shareholder or intermediary must tell us what accounts should be included for ROA or LOI at the time of the purchase.

Will you allow shareholders to exchange between the new Delaware Funds on the FIS system and the Delaware Funds on the BNY Mellon system?

No. Exchanges between the Delaware Funds on the FIS system and BNY Mellon system will not be allowed. However, shareholders do have the ability to redeem and purchase at NAV across the transfer agent systems. Exchanges will be allowed once the new Delaware Funds transition to the BNY Mellon system in 2020.
