### Diamond Small Cap Fund

Effective at the close of business on December 31, 2015, the Diamond Hill Small Cap Fund will close to most new investors. At this time, the Fund will remain open to additional investment from existing shareholders and certain other new accounts as described in the prospectus supplement dated November 6, 2015.

**Unless communicated to you separately, effective December 31, 2015, your firm will no longer be permitted to open new accounts/clients in the Fund.** Only existing accounts/clients may continue to purchase and add to their investment in these share classes.
