### Fund Mergers: Effective October 20, 2017

American Century New Opportunities Fund American Century California Long-Term Tax-Free Fund

Effective October 20, 2017, the New Opportunities Fund will merge into the Small Cap Growth Fund. The decision to merge these funds is based on the similarity in philosophy and investment objectives. Both funds are managed by the same team and have a large overlap in holdings.

Also, effective October 20, 2017, the California Long-Term Tax-Free Fund will merge into the California Intermediate-Term Tax-Free Fund. The decision to merge these funds is based on the similarity in philosophy and investment objectives – safety of principal and high current income that is exempt from California state and federal income taxes.

October 17	After the close of business, no purchases will be accepted (except reinvested dividends and capital gain distributions). New accounts established by registration transfer into the closed fund(s) will be permitted.
October 18	Any required income distributions will be paid.
October 19	Final trade date for processing redemptions and exchanges through the NSCC.
October 20	Final trade date for processing manual redemptions and exchanges. NAV price for merger will be two decimals. Merger ratios, rounded to nine decimals, available Friday evening.
October 21	Networking Activity Records (F55) generated and sent with a transaction type of W0 (Fund Merger Non-Taxable)

### Fund Liquidations: Effective October 20, 2017

American Century Emerging Markets Value Fund American Century Global Allocation Fund

American Century Clobal Anocation Fund

Effective October 20, 2017, the American Century Emerging Markets Value Fund and American Century Global Allocation Fund will be liquidated. The decision to liquidate these funds was based on the funds not differentiating themselves among our current lineup and low client demand for these types of products.

October 17	After the close of business, no purchases will be accepted (except reinvested dividends and capital gain distributions). New accounts established by registration transfer into the closed fund(s) will be permitted.
October 18	Any required income distributions will be paid.

October 20	Final trade date for processing manual redemptions and exchanges. For remaining assets held through financial intermediaries, all outstanding shares will be liquidated by wire or check, at the direction of the intermediary.
