Monday, December 3, 2018

- ACATS transactions placed through the NSCC will be restricted on the closing fund CUSIPs effective end of day December 3, 2018.
- All NSCC trades placed in the closing funds will default to T+1 settlement through the merger date.

Wednesday, December 5, 2018

• Any NSCC purchases and exchanges placed into the closing funds will be hard rejected through the merger date and will need to be placed manually

Thursday, December 6, 2018 (Revised)

All closing fund CUSIPs are scheduled to go ex-dividend, but closing funds may not pay out.

Friday, December 7, 2018

- Investments in the closing funds' CUSIPs will automatically be converted to shares of equal dollar value of the acquiring fund CUSIPs at the close of business.
- A special 4 decimal NAV will be used to calculate the value of the closing fund shares and a 2 digit regular decimal NAV will be used to calculate the shares in the acquiring fund.
- No purchases will be accepted in the closing CUSIPS. Purchases should only be placed in the acquiring CUSIPS.
- NSCC redemptions in closing funds will need to be placed manually. Those redemptions would be processed with a four digit NAV.
- Closing funds are end-dated on December 7, 2018.
