1. Prudential Mutual Funds to be renamed PGIM Mutual Funds

Effective June 11, 2018, mutual fund names will be preceded by "PGIM" and no longer include "Prudential" in their name. For example, the Prudential Total Return Bond Fund will now be the PGIM Total Return Bond Fund.

This is a name change only. Generally, this renaming will not affect the management, symbols or CUSIPS of the funds.

Important Note: On June 11, 2018, any search performed for our funds should be done using PGIM, versus Prudential. All data reporting systems (e.g. Morningstar, Lipper, etc.) are expected to reflect the updated fund names around this time.

Renaming our funds more closely aligns them to our firm, which renamed to PGIM Investments in April 2017. Additionally, it helps accelerate brand awareness around PGIM, the global investment management businesses of Prudential Financial—a top 10 global asset manager¹ with over \$1 trillion in assets under management².

While it won't be necessary to amend existing agreements because of the change in the names of the funds, we will be sending a communication to each of our counterparties providing notice and an explanation of the changes.

Exception:

• Day One Funds: Our target date fund suite will keep the Prudential name and will not be changed.

2. Additional Name Changes: Prudential QMA Strategic Value Fund and Prudential Jennison Emerging Markets Equity Fund

In addition, we will also be renaming two domestic funds on June 11, 2018 to prevent duplicative names across our global platform and to make their names consistent with other offerings managed by their respective portfolio management team. The change will not affect the management, symbols or CUSIPS of either fund.

3. Prudential Closed-end Funds to be renamed PGIM Closed-end Funds

Effective on June 11, 2018, our closed-end funds will be preceded by "PGIM" and no longer include "Prudential" in their name. For example, the Prudential Short Duration High Yield Fund, Inc. and Prudential Global Short Duration High Yield Fund, Inc. will now be named the PGIM Short Duration High Yield Fund, Inc. and the PGIM Global Short Duration High Yield Fund, Inc., respectively. The management of these funds along with the fund tickers will remain the same. The name change will generate new CUSIPS for the closed-end funds which will be communicated and provided at a later date.

4. Reminder of other share class updates

As previously communicated, several other share class changes will become effective in June 2018. These include:

- Effective June 1, 2018:
 - o Adding Class R4 and R2 share classes to select funds, which will be available for purchase by group retirement plans
 - Class Z, Class A, and Class C shares for all Prudential Funds generally will be closing to new group retirement plans wishing to add the funds as new additions to plan menus
 - o Closing Class R share purchases generally to all new investors

Effective June 11, 2018:

• Renaming Class Q shares to Class R6 shares for all funds
