Updates to the Goldman Sachs Money Market Fund Lineup

Announcement

Goldman Sachs Asset Management ("GSAM") is pleased to announce changes to our Money Market Fund product lineup and related processing environments.

Summary of Fund Updates

Please see below for a summary of these changes and Fund details. For more information, please refer to the prospectus sticker filed on April 15, 2016.

Institutional (Floating NAV) Funds

- 1a. The Goldman Sachs Financial Square Prime Obligations Fund, Financial Square Money Market Fund and the Financial Square Tax-Exempt Fund will operate as "institutional money market funds," as defined by amended Rule 2a-7. These Funds will not change their investment policies and will comply with floating NAV and liquidity fees and redemption gates requirements upon their transition. We expect that all three portfolios will begin transacting at a FNAV on or around October 1, 2016. We will provide further clarity of the transition date as we get closer to October.
- 1b. Effective on or about August 31, 2016, check writing privileges will no longer be available for investors in Institutional Funds. If checks are presented after the August 31, 2016, they may not be honored.
- 1c. In addition, on or about the October 1, 2016, investors will no longer be permitted to exchange shares from or into the Goldman Sachs Financial Square Money Market Fund and the fund will no longer be eligible for NSCC trading.
- 1d. Please be advised that on or around October 1, 2016, the fund closing time, for both redemption and purchase trades, for the Financial Square Tax-Exempt fund will change to 2:00 P.M. ET. We will provide more details as we get closer to October.

The Goldman Sachs Investor Money Market Fund and Investor Tax-Exempt Money Market Fund will operate as "retail money market funds," as defined by amended Rule 2a-7 by the regulatory deadline of October 14, 2016. These Funds will not change their investment policies and will comply with a stable NAV and liquidity fees and redemption gates upon their transition.
- 3b. Effective July 29, 2016, new accounts that are not beneficially owned by natural persons will not be eligible to invest in the Retail Funds. Beginning on August 31, 2016 the Retail funds may involuntarily redeem all investors that do not satisfy these eligibility requirements. Authorized Institutions will be required to take steps to remove any shareholders that are not eligible to invest in the Retail Funds and must notify the Retail Funds of any ineligible shareholders that continue to own shares of the Retail Funds by August 31, 2016.
- 3c. Please be advised that on or around October 1, 2016, the fund closing time, for both redemption and purchase trades, for the Investor Tax-Exempt fund will change to 2:00 P.M. ET. We will provide more details as we get closer to October.
