

Important Information FARF Reorganization Schedule Update

July 18, 2019

On July 17, 2019, shareholders approved the reorganization of **Federated Absolute Return Fund (FARF)** into **Federated Global Allocation Fund (FGALF)**, effective after the close of business on **August 16, 2019**. The reorganization is anticipated to be a tax-free event for shareholders of the Funds.

Conversion ratios will be provided after the close of business on August 16, 2019.
