Invesco continuously and carefully evaluates the changing market environment as well as the level of flows into, and overall assets in, the fund and the International Growth strategy as a whole. As a result of our ongoing evaluation and these recent trends, we believe we are now in a position to reopen the fund to new investors.

Fund management will continue to monitor market conditions and opportunities affecting ongoing capacity. If conditions warrant, the team may choose to once again close the fund at a future date.
