Effective Nov. 1, 2018, the Invesco Emerging Markets Equity Fund will change its name to the Invesco Emerging Markets Select Equity Fund.

Effective Nov. 30, 2018, The Invesco International Companies Fund will change its name to the Invesco International Select Equity Fund.

Who is the Invesco Global Select Equities team?

The Invesco Global Select Equities (GSE) team is a distinct portfolio management group within Invesco that follows the "FORS" investment approach (the acronym FORS represents the investment process: Free cash flow, Organic growth, Return on invested capital, and Sustainable competitive advantage). The emerging markets and international equity funds are being renamed to identify them as part of this team and philosophy.

Why are we making these changes?

The goal of the portfolio management addition is to consolidate like-minded teams across different investment centers, strengthen the team and enhance our emerging markets capabilities globally.

Mr. Feng has twenty years of experience in the industry and joined Invesco in 2009. He is currently managing two Canadian emerging markets mandates. In addition, his EM research is leveraged in all the other global mandates managed by the GSE team.

Ms. Baker and Mr. Feng are both senior portfolio managers who will work together in managing the GSE team's emerging market investment strategies, products and team members.

In addition, the name changes to Invesco Emerging Markets Select Equity Fund and Invesco International Select Equity Fund will align to the naming convention of the products managed by the GSE team.

Will the addition of Mr. Feng affect the investment objective or investment philosophy and process for the Invesco Emerging market fund?

No. Although Mr. Feng previously managed a different emerging markets mandate, his investment philosophy and process are similar to Ms. Baker's. Ms. Baker and Mr. Feng both focus on high quality businesses with strong competitive advantages and management teams. They look at investing in companies that meet their high standards and also focus on companies that are trading at an attractive discount to their intrinsic value. The Fund will continue to be a concentrated, high active-share portfolio with a long investment horizon.
