As previously communicated, the Board of Trustees approved a merger of the INTECH U.S. Core Fund into INTECH U.S. Managed Volatility Fund, subject to shareholder approval. This merger was expected to occur on **Friday, May 5, 2017**.

Please note that due to the delay in obtaining shareholder approval of the merger the initial merger date of Friday May 5, 2017 has been moved to <u>Friday</u>, <u>June 23, 2017</u>.

The revised merger date falls after the Janus Capital Group Inc. and Henderson Group plc. Plan of Merger and the associated mutual fund operational events, including fund renames, which take effect on June 5, 2017. See below for CUSIP information.
