Revised Fund Liquidation | JPMorgan Multi-Cap Market Neutral Fund

The liquidation date of the **JPMorgan Multi-Cap Market Neutral Fund** has been revised to **March 28, 2018** from the previously communicated date of April 6, 2018 due to redemption activity. Please see the attached supplement for additional information.

As a result of the revised liquidation, the bolded dates below have also been revised:

- For existing shareholders of record as of March 19, 2018, additional purchases will be accepted up to and including **March 23, 2018**. No other purchases will be accepted.
- Effective March 19, 2018, NAVs have been extended to 4 digits.
- The final trade date for DCC&S redemptions will be March 27, 2018.
- The final trade date for redemptions and exchanges out via the NSCC will be March 28, 2018. If you are placing trades on March 28 via the NSCC, please notify ipmorgan.funds.intermediary.svcs@ipmorgan.com.
