Effective close of business on September 15th, 2017, the Century Shares Trust will be reorganized into the Congress Funds (a series of the Professionally Managed Portfolios) under the shareholder approved Plan of Reorganization. As a result of this conversion and fund reorganization, Shareholder Servicing and Transfer Agent Services will now be handled by US Bancorp Fund Services, LLC effective Monday, September 18th, 2017
