Dear Business Partners:

Oppenheimer Institutional Money Market Fund may close early on any day that the New York Stock Exchange (NYSE), the Federal Reserve Bank of New York, and/or the bond market closes early, as recommended by The Securities Industry Financial Markets Association (SIFMA). Although there may be exceptions, the Fund will typically be consistent with SIFMA's U.S. holiday recommendations and will close to purchases and redemptions at 2:00 p.m. Eastern Time on those dates. Holidays that the Fund will close on are shown below, and are also available on SIFMA's website.
