Effective December 28, 2016, Oppenheimer International Value Fund will be renamed Oppenheimer International Equity Fund. The new name better reflects the Fund's investment process, which favors a blend/core approach. There will be no change to the Fund's portfolio management, investment objective or Morningstar category (currently the product sits in Foreign Large Blend). The Fund's benchmark will remain the MSCI ACWI ex-U.S.
