The Oppenheimer Equity Fund ("Fund") shareholder meeting referenced in our February 6, 2017, communication was held earlier today, February 10, 2017; however, quorum was not met and the meeting was adjourned to February 24, 2017. At this time, there are no purchase restrictions for the Fund. An additional proxy mailing will be sent to garner the votes necessary to reach quorum. If the proposal is approved at the February 24, 2017, shareholder meeting, no new accounts may be established in the Fund effective February 27, 2017. The proposed reorganization details are provided below. An update will be provided to your firm after the shareholder meeting on February 24, 2017.
