

As we announced in January, Vanguard Target Retirement 2010 Fund (Ticker VTENX, CUSIP 92202E706) will be merged with Vanguard Target Retirement Income Fund (Ticker VTINX, CUSIP 92202E102). We also announced that Vanguard Institutional Target Retirement 2010 Fund (Ticker VIRTX, CUSIP 92202E821) will be merged with Vanguard Institutional Target Retirement Income Fund (Ticker VITRX, CUSIP 92202E698). Both mergers will occur in July 2017.
