Emerging Markets Equity Fund and Municipal Money Market Fund to reopen certain share classes

The *Wells Fargo Advantage Emerging Markets Equity Fund* will reopen to investors at the start of business on December 1, 2015. All classes of the fund have been closed to new investors, with certain exceptions detailed in the fund's prospectus and statement of additional information, since December 31, 2013.

The Institutional Class of the *Wells Fargo Advantage Municipal Money Market Fund* will also reopen to investors at the start of business on December 1, 2015. Please note that the *Wells Fargo Advantage Funds* Board of Trustees has designated this fund as a retail fund and will limit investors to natural persons, effective on or before October 14, 2016.
