## Holiday trading hours for 2016

The 2016 holiday trading schedule anticipated for Wells Fargo Funds is below. Wells Fargo Funds generally follows the holiday schedules of the New York Stock Exchange (NYSE) for the stock market and the Securities Industry and Financial Markets Association (SIFMA) for the bond market.

A reminder will be sent before each holiday, including any changes that may occur.

**Note:** On September 26, 2016, we updated the money market fund closing times to state normal hours on early-close days for the Cash Investment Money Market Fund and the Heritage Money Market Fund because these funds will close at 3 p.m. ET every day effective October 5, 2016.
