Change to name and distribution frequency for the Wells Fargo Dow Jones Target Date Funds

At the start of business on July 14, 2017, several enhancements will take effect for the Wells Fargo Dow Jones Target Date Funds, including the following:

- The funds will be renamed the Wells Fargo Target Date Funds. The funds' tickers, CUSIPs, and transfer agent (TA) numbers will not change.
- The distribution frequency will change to annually for all funds in the suite except for the Wells Fargo
 Target 2010 Fund, the Wells Fargo Target 2015 Fund, and the Wells Fargo Target Today Fund, which
 will remain quarterly.
