## Update to changes to the Wells Fargo Small Cap Opportunities Fund

On March 2, 2018, Wells Fargo Asset Management (WFAM) announced proposed changes to the Wells Fargo Small Cap Opportunities Fund, including a fund name change. If approved by shareholders, the changes will be effective on June 27, 2018. Please note that the changes will not affect the fund's share classes, ticker symbols, transfer agent numbers, or CUSIPs.
